I am directed to say that the State Government has been paying additional honorarium to the Anganwari Workers/ Anganwari Helpers in addition to the normal honorarium as being paid by the Govt. of India and State Government as well.

For some time past it has been under active consideration of the State Government to enhance the rate of additional honorarium to the Anganwari Workers/ Anganwari Helpers.

Now, in continuation of this Department's earlier Order No. 192(2)-SW/FS dated.22.06.2010, I am directed by the order of the Governor to say that the Governor has been pleased to enhance the additional honorarium of the Anganwari Workers and the Anganwari Helpers of both Government run ICDS Projects and NGO run ICDS Projects @ Rs.500/- p.m w.e.f 01.04.2017.

The total amount of additional honorarium of both Anganwari Workers and the Anganwari Helpers comes to Rs.1850/- p.m w.e.f 01.04.2017.
