In continuation to above mentioned letter, this is to inform you that with the distribution of THR to the beneficiaries of ICDS, Morning Snacks to all beneficiaries and Special Supplementary food for the Severely Underweight Children in the form of RTE packets will also be provided along with THR in the following manner as per order no. 7278-SW/O/3S-289/12 dated 16 October, 2019 of the Joint Secretary of the Department (Copy Enclosed).

The THR in the form of RTE will also be provided along with this distribution to Out of Adolescent Girls (11-14 years) for the month of July 2021 in the following manner:

1.	Other Children of 06 (six) months to 06 (six) years	1 (one) packet of 480 grams per child per month	Green
2.	Severely Malnourished Children of 06 (six) months to 06 (six) years	5 (five) packets of 480 grams each per child per month	Orange
3.	Adolescent Girls (out of school 11 - 14 years)	4 (four) packets of 1200 grams each per Adolescent Girl per month	Blue

The RTE will be will be procured from the SHGs / Clusters / Federations already approved or prospectively approved by the Department for manufacturing and supply of Ready-to-Eat Nutritional Mix.

You are requested to instruct the DPO (ICDS) of your district accordingly.

 Sub. : Revised Cost of Morning Snacks and THR for Severely Malnourished Children.

Sir / Madam,

I am directed to bring to your notice that the details of SNP Menu for the targeted beneficiaries of 6 months to 6 years of children and pregnant and lactating women under Anganwadi Services and 11 to 14 years of out of School Adolescent Girls under Umbrella ICDS Scheme, have been communicated vide this Office Memo No.2877-SW/3S-289/12 Dated 08.06.2018 and Office Memo No.6898(24)-SW/14011/6/2018 Dated 17.12.2018 respectively. Causing uniformity in Composition, Quantity and Cost of Ready to Eat (RTE) Nutritional Food (Pushti) as Morning Snacks for the targeted beneficiaries (children of 6 months to 6 years) under Anganwadi Services, THR for 11 to 14 years out of School Adolescent Girls and Severely Malnourished Children (6 months to 6 years) were under consideration of this Department for sometimes. This Department has aligned the composition and the cost of RTE, to bring uniformity as follows :



RTE named as 'Pushti' is to be provided to all children (6 months to 6 years) as Morning Snacks with a quantity of 40 grams per head per day with a cost of Rs.1.90/-. Similar RTE (Pushti) as THR is to be provided to all the Severely Malnourished Children (6months to 6 years) with a quantity of 480 grams per head per week with a cost of Rs.22.80/- apart from Morning Snacks. It is decided that the surplus cost of Rs.0.18/- (Rs.2.08 - Rs.1.90) per head per day will be added to the cost of Banana as part Morning Snacks. Cost of existing rate of banana is therefore enhanced to Rs.2.18/- (Rs.2.00 as existing cost of banana + Surplus Rs.0.18).

It is also decided that surplus cost of Rs.4.80/- [{Rs.24.00/- per week as existing cost of THR - Rs.22.80/- per week as revised cost of THR = Rs.1.20/- per week (surplus)} x 4 weeks in a month] per head per month for Severely Malnourished Children aged 6 months to 6 years shall be utilized to provide 150 grams of Suji (Semolina) packet monthly.

I am therefore directed to request you to implement the revised rate of banana in the Morning Snacks and introduce 150 grams Suji (Semolina) Packet monthly to each Severely Malnourished Children from 6 months to 6 years in addition to RTE (Pusti) as THR.
