Formation of Child Protection committees

The process of CPCs formation will be initiated by District child Protection Unit. The process will include formation of BLCPC and in urban area the ULB level CPC. After the BLCPC is formed the GPLCPC and VLCPC formation process will be initiated.

Roles and Responsibilities of Child Protection Committees

- The Child Protection Committees at various levels will be responsible for the following:
- Conduct Need assessment in prescribed format for planning.
- Prepare annual plan and allocate budget as a part of Panchayat/ULB planning.
- Identify vulnerable pockets, maintain data of children and adolescents missing due to work, marriage, migration, school dropouts or by any other reason.
- Support referral linkages with Social protection schemes & services, support persons, conduct enquiries and submit reports on complaints received, action taken and preventive activities planned.
- Organize capacity building and orientation on child protection issues in collaboration with district/block/Panchayat administration along with CBOs, NGOs, adolescent groups, and other stakeholders.
