4. Further, it is requested to submit a report of the girls identified district wise, mapped in the PRABANDH portal and referral made thereof latest by 31st May, 2022. Funds to incentivize AWWs will be released upon submission of reports.

Once it was verified at district level, then the girl will appear in the WCD mapping module.
- Enter the Anganwadi Code (this code is mandatory to verify the Anganwadi center)
- Once Anganwadi code was entered , the portal will validate the Anganwadi Code . If Code is correct then the Anganwadi Center name will be displayed (*Note : Without the Anganwadi code, the data will not be mapped on portal*)
- Click the Save (🛅) button to save
- To Reset the Anganwadi Center Girl Student , click the Red Cross button (😫).
- Use the Lock button (Lock) to lock this child permanently. The data once locked , cannot be resettled
