I am directed by the order of Governor to say that Governor has been pleased to enhance the **honorarium** for the Anganwadi Workers (AWW) from existing Rs.3000/- per month to Rs.4500/- per month and for the Anganwadi Helpers from existing Rs.1500/- per month to Rs.2250/- per month w.e.f 01.10.2018 in the light of the letter communicated by Ministry of Women & Child Development, Government of India vide its letter No.11-36/2016-CD.I dated.20.09.2018 , as per the prescribed cost Sharing ratio with the Government of India and State.
