**Sub: Distribution of THR in the form of RTE among Out of School Adolescent Girls of 11 to 14 Years under Scheme for Adolescent Girls for SAG Beneficiaries for the months of January, February and March, 2022**

Sir/Madam,

With reference to above subject, this is to inform you that for those districts where the approval to SHGs for supplying RTE has already been awarded by the Department (as per Memo Nos enclosed herewith) and the SHGs are ready to supply RTE, the Out of School Adolescent Girls of 11 to 14 years in those districts will be provided RTE @ 4 (four) packets of 1200 gm each per Adolescent Girls per month for the months of January, February and March, 2022..

But for the districts where approval of SHGs for supplying RTE is still pending, those districts may procure RTE from the adjoining districts, which are manufacturing RTE.

The distribution of RTE should be made strictly as per no. of Adolescent Girls entered in the "Sakhi Portal" for the month of January and February, 2022.

Precautionary COVID protocol measures in terms of social distancing; wearing of mask and sanitization should be taken care of while carrying forth the above THR distribution. Unnecessary gathering should be avoided during house to house distribution.

. The distribution of THR shall be completed within 31.03.2022.
