Sub: Registration of Implementing Agency (I.A.)

Madam/Sir,

This is to inform that consequent to transition from IFMS to PFMS module, payments towards the CSS under ICDS will be made through PFMS Portal while Salary, Additional Honorarium, Fuel & Condiments, Transport & Storage and other expenditures borne fully (100%) by State Government will be billed through IFMS portal.

The District Magistrates are hereby nominated as Implementing Agency (I.A.) for making payments in respect of the District ICDS cells.

In respect of NGO run ICDS Projects (if present in the District), the concerned Sub-Divisional Officer (SDO) will be the Implementing Agency (I.A.) of the NGO project. The CDPO of the concerned NGO project will be the Data Operator (D.O.) while SDO himself or any other Officer to be designated by the SDO not below the rank of Deputy Magistrate will act as Data Approver (D.A.).

The Accounts Officer, Directorate of ICDS, will act as the IA of the Directorate of ICDS as well as the IA of Burtala NGO run ICDS Project. The District Programme Officer, Kolkata will be the IA of District ICDS Cell Kolkata and the CDPO, Red Light Area, NGO run ICDS project, Kolkata will act as IA of the project.

Registration of the District Magistrate or the Officer to be designated to act as IA on behalf of the District Magistrate and Sub-Divisional Officer as IA have to be made in PFMS Portal for which the details are required as per the format below.


