Sub: **Date and time-span for distribution of THR among Out of School Adolescent Girls of 11 to 14 Years under Scheme for Adolescent Girls**

Sir/Madam,

With reference to the Directorate order mentioned above it is further notified that to ensure continuation of uninterrupted distribution of THR during 2<sup>nd</sup> phase under Scheme for Adolescent Girls during times of Covid Pandemic it has been decided that 2 (two) kg of Rice, 300 (three hundred) gm of Musur Dal and 1 (one) Kg of chhola will be provided to aforesaid beneficiaries by the Anganwadi Worker / Anganwadi Helper, maintaining social distancing norms. The process of distribution must be completed by 30<sup>th</sup> September, 2020.

As the THR stated above is not under ICDS SNP, the procurement will be made by the anganwadi workers separately and bill for this procurement will be met out of SAG Nutrition component fund which will be allotted for the purpose shortly. As per Department Order No 1798 (2) - SW / WCD-14023/1/2018 dated 02.06.2020 and this Directorate order No - 1083 (23) / ICDM - Dte dated 31.07.2020, the rate of rice (fine) IR - 36 has been fixed as Rs. 27/- per Kg, Masur dal (small variety) at the rate of Rs. 90/- per Kg and Chhola at the rate of Rs. 52/- per Kg in reference to the No.2992/1(48)-SW/WCD-14038/1/2020 dt.15.09.2020.

Necessary arrangement may be done for smooth distribution.
